Summary

The Fine Dining Server is responsible for serving members and guests with food and beverage menu items, making recommendations, setting dining room table and sidebars, and collecting payments. The server may assist bartenders and event servers as needed for specific activities. The server must maintain knowledge and understanding of menu offerings. No supervisory duties are included in this position.

Essential Duties & Responsibilities

- Set up station and performs assigned work.
- Greet members and guests and provide immediate attention upon seating.
- Distribute menus ; fill water glasses; answer questions and make recommendations for menu items.
- Take member/guest orders, place orders with kitchen as prescribed. Inform chef/cooks of special cooking instructions.
- Assemble food on tray; serve meal, placing dishes by course in front of each person.
- Serve beverages (alcoholic and non-alcoholic) to members/guests; verify age requirements for the purchase and consumption of alcohol.
- Check back with member/guest to ensure satisfaction, replenish water and condiments as necessary; remove soiled dishes.
- Suggest and serve dessert, coffee and after dinner/meal drinks.
- Present and collect payment of bill; verify appropriate billing account for member/guest charges.
- Handle all cash and credit card payments according to Club policy and procedure.
- Maintain all dining areas, tables, and bus station areas in a clean and orderly state.
- Advise supervisor, Dining Room Captain, or appropriate shift leadership of any complaints as they are received.
- Perform clean-up and closing duties as assigned.
- Attend pre-meal/pre-shift meetings as requested or as assigned by supervisor or Dining Room Captain.
- May use Club vehicles to transport supplies, sundries, and similar in support of bar and event operations.
- May assist event servers, bussers, food expeditors, and event servers in support of Food & Beverage operations.
- Perform other related duties as assigned.
